### Fees

**Event participation fee  
per one representative of the participant \*** € 100.00

\* the participant means one business entity

**Each additional representative of the participant will pay extra fee of € 50.00**

The participant will indicate the number of his representatives in the registration form upon online registration for the event.

**All fees related to the international payment are incurred by the participant!**

#### Participation fee includes:

- the entry of the participant in the matchmaking schedule of bilateral meetings
- announcement of the participant in the event catalogue
- the welcome glass of wine

- the participation at the Gala Dinner
- refreshments

#### No cancellation fee till October 17, 2016.

Paid participation fee will be returned in full upon written notice of cancellation ([matchmaking@sario.sk](mailto:matchmaking@sario.sk)).

In case the participant cancels the participation in writing (at [matchmaking@sario.sk](mailto:matchmaking@sario.sk)) in the period of October 17, 2016, until October 24, 2016, only 40% of the paid amount will be returned to his account due to the administration costs of SARIO resulting from the registration of the participant.

In case the participant cancels the participation in writing (at [matchmaking@sario.sk](mailto:matchmaking@sario.sk)) ) after October 24, 2016, the fee will not be returned to the participant, due to inevitable administrative costs of the SARIO agency related to registration and matchmaking of the participant for the bilateral negotiations.

**In case the participant registers for the Slovak Matchmaking Fair 2016 but fails to pay the registration fee on time until October 20, 2016, he would not be included in the matchmaking process and B2B meetings!**
